Webinar To Discuss the Challenges and Opportunities of Keeping Families Together in Your FTC

Description: This webinar will explore key values and principles that are essential for serving the in-home population and planning considerations for FTCs that want to serve intact families. Various practice innovations will be highlighted, including jurisdictions that implement a pre-file model which serves families prior to the filing of petition, and developing Plans of Safe Care for mothers and their infants as required by the Child Abuse Prevention and Treatment Act. This webinar will also highlight the importance of quick access to treatment, identifying protective factors when assessing parental capacity and child risk and safety, communication between partner agencies, and safety planning.

Webinar To Discuss the Effects of Trauma on Brain Function

Date: Tuesday, September 24, 2019

Time: 3:30-4:30 p.m. ET



Description: This webinar will address how trauma responses, protective during traumatic experience, change our brain function and physiology in ways that are not subject to our voluntary control. It will explain how those changes can result in negative impacts to our functioning, thinking, relationships, and work if they are not addressed. Participants will learn why we can't just decide to make the effects of trauma recede, based on recent brain science. The webinar will address why we need to learn skills that actually address the changes in brain function during trauma to prevent negative effects. Skills for addressing trauma responses during traumatic experiences that are not dangerous and immediately post-trauma exposure will be presented.
